Anne Lange joined the [German Police University \(GPU\)](#) as a research associate in October 2020. She currently works on the evaluation of security sector reform (SSR) programs worldwide. She is part of the team evaluating the German civilian engagement in Afghanistan.

Anne Lange holds a PhD in Political Science. Her research focuses on international peace and security operations (in particular UN and EU missions). She is particularly interested in the role of the police in international peace and security operations and in SSR programs, and in how cooperation between stakeholders in these operations is organized. She conducted field research in Haiti, Kosovo, Western Sahara/Morocco, Timor Leste und Tunisia as well as “online” field research in South Sudan. She is a member of

the *Academic Council on the United Nations System (ACUNS)* and the *United Nations Association of Germany (Deutsche Gesellschaft für die Vereinten Nationen e.V., DGVN)*.
